Customer Engagement Monthly Round Up



The second Engagement Tour of the month took place at Rose Tree Community Centre on Thursday 18 April. 11 tenants came out to speak to us. We asked them to prioritise what was important to them as tenants, with ASB being the top priority. Neighbourhood Officers at the event will take this forward.



Great Houghton TARA are busy organising their very popular annual trip to the seaside, which this year will be to Scarborough. The group have been organising this kind of activity for more than 30 years and will take two full coaches. It's a very much looked forwarded to event by the residents of Great Houghton.



We held the Annual Report Meeting at Gateway Plaza on Tuesday 30 April. Seven tenants attended, giving their thoughts on the content, layout and case studies, offering a tenants perspective on the draft version of the Annual Report.

Recruitment for a tenant board member and the new Executive Director of Resources have begun. We had five involved tenants sit on stakeholder panels to meet with candidates and have a chat. This was a great opportunity for involved tenants to be part of the recruitment process.

- Our fantastic Building Fire Safety Residents Panel held their meeting to discuss and contribute to our new Building Fire Safety Engagement Strategy on Monday 8 April. They have called a follow up special meeting on Tuesday 30 April to agree amendments and sign off the document.
- We've been busy promoting our Engagement Tracker within Berneslai Homes.
 This helps us to identify the impact of engagement, any gaps we have and demonstrate the difference it makes to tenants.
- The involved tenants attended two meetings in Gateway Plaza this month. As well as the Annual Report meeting the Tenant Voice Panel met to look at future development and training needs.
- We've reflected on our Engagement Tours and we've refocussed the questions to find out more about you, your priorities and the different ways you can give us your views.
